

Valet Parking Term & Conditions - Aafaq Credit Cards



Valet Parking Service:

Is a service offered by a third party for putting eligible specific Aafaq Credit Cardholders vehicles in a parking slot.

Description:

Eligible aafaq Credit cardholders can enjoy a complimentary standard valet parking service up to 2 visits per month across selected locations in the UAE.

Conditions:

- Cardholder must have a minimum retail spend of AED 3000/- in the previous calendar month (Spends include POS & E-Commerce) Balance transfer, Cash on call, fees & charges are excluded.
- If cardholder does not maintain the minimum spend condition, card will be charged for AED 100/-
